Product Warranty for Express Clean Automatic Injection System

Revised September 2019

I. What this Limited Warranty Covers & For How Long

Girbau North America, Inc. (Girbau), Oshkosh, WI 54904 extends this limited warranty to the original owner (Purchaser), or by factory authorized warranty transfer to a new owner, of Express Clean.

Girbau will repair or replace, free of charge, limited parts which fail as a result of a defect in material or workmanship for a period of two years (24 months) beginning on the date of purchase. This includes display boards, microprocessor boards and LED lights.

II. What this Limited Warranty Does Not Cover

- Girbau will not provide replacement of any part which fails for reasons other than defective material or workmanship. This includes, but is not limited to, failure as a result of abuse, misuse, chemical incompatibility, improper installation or maintenance and transportation damage.
- Consumables, such as squeeze tubes, tube connectors and tube associated fittings, are not covered by this limited warranty.
- Girbau will not honor this warranty for parts which have been altered without the written consent of Girbau's President, or if parts have been altered in any way, so as in the judgment of Girbau, to adversely affect the stability or reliability of the Equipment or parts.
- Girbau will not honor this warranty if parts from a manufacturer other than Girbau have been incorporated on the Equipment or if parts have been incorporated which have not been purchased from Girbau.
- Girbau is not responsible for labor, freight or transportation costs incurred in the replacement of any part.
- Girbau is not responsible for any consequential damage resulting from any malfunction.
- Girbau is not be responsible for, and rejects liability for, any part failure if such failure is due to an act of God, natural disaster, vandalism, intentional infliction of damage or dereliction.
